**Emergency Procedures**

As a water based product, if spilt on electrical equipment the product will cause short-circuits. Place inert absorbent material onto spillage. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

## 7. HANDLING AND STORAGE

**Precautions for Safe Handling**

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene by washing hands prior to eating, drinking, smoking or using toilet facilities.

**Conditions for safe storage, including any incompatibilities**

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Protect from freezing. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Occupational exposure limit values**

Phosphoric acid

TWA: 1 mg/m<sup>3</sup>

STEL (Short Term Exposure Limit): The average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

#### Appropriate Engineering Controls

Use with good general ventilation. If mists or vapours are produced, local exhaust ventilation should be used.

#### Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapour filter should be used. Reference should be made to Australian/New Zealand Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

#### Eye Protection

Safety glasses with side shields, chemical goggles or full-face shield as appropriate should be used. Final choice of appropriate eye/face protection will vary according to individual circumstances. Eye protection devices should conform with Australian/New Zealand Standard AS/NZS 1337 (series) - Eye Protectors for Industrial Applications.

#### Hand Protection

Wear gloves of impervious material such as rubber or PVC. Final choice of appropriate gloves will vary according to individual circumstances i.e. methods of handling or according to risk assessments undertaken. #### Body Protection

Suitable protective work wear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.
