4. FIRST-AID MEASURES

Inhalation

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. 6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Collect the material and place into a suitable labelled container. 7. HANDLING AND STORAGE

Precautions for Safe Handling

Use only in a well ventilated area. Keep containers closed when not in use. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area away from sources of ignition, oxidising agents, foodstuffs, and clothing. Keep containers closed when not in use and protected against physical damage. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. Ensure that storage conditions comply with applicable local and national regulations.
